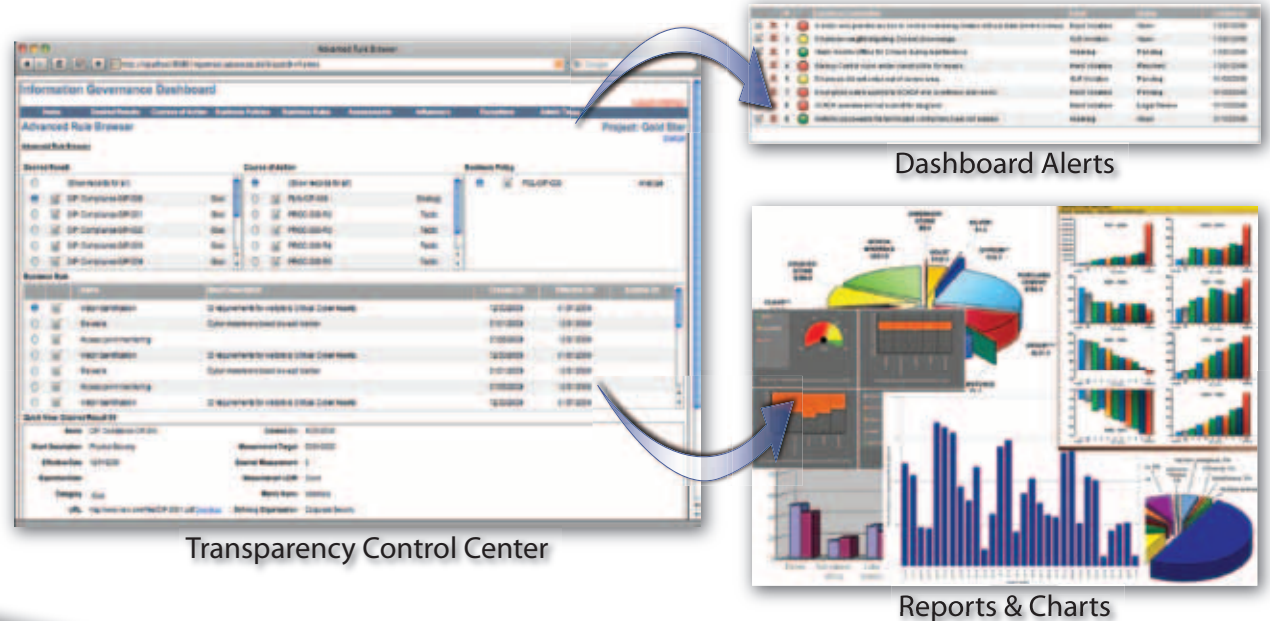

- Vocabulary and Rules – a component to manage vocabulary and rules that are both industry-specific and customizable by corporate policy makers

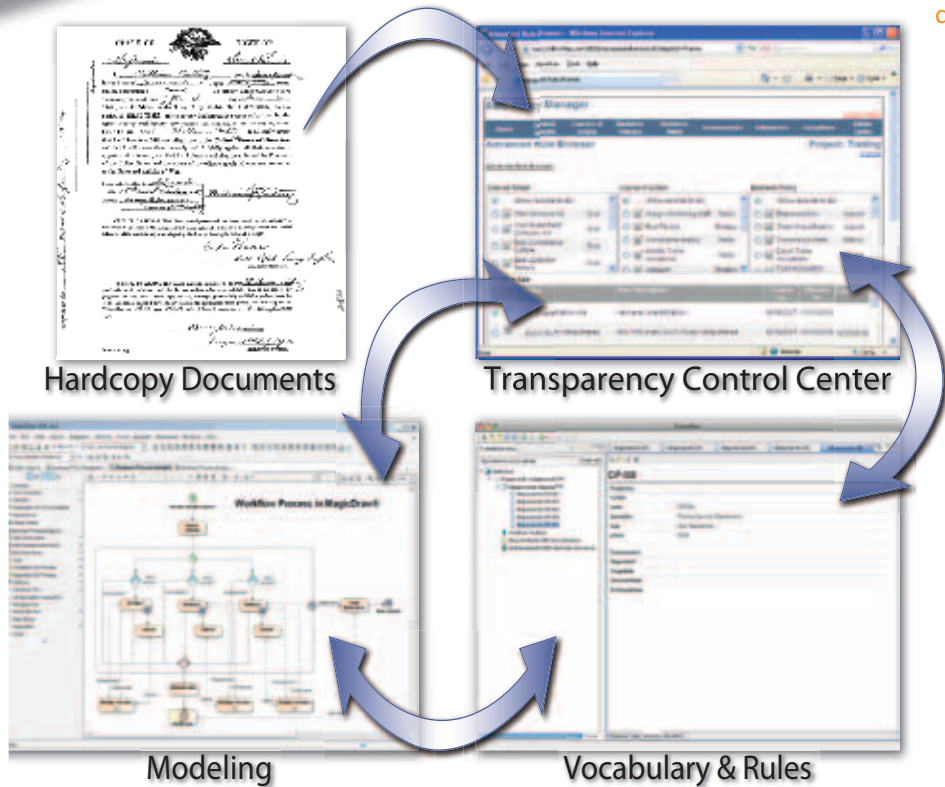

ALIGN GOALS AND POLICIES

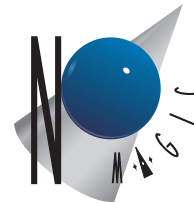
